

# 1963 - 1966 Corvette: Chevrolet Letter: Corvette Body Repair Molds

**Subject:** Corvette Body Repair Molds

Lloyd English and Roger Mudd from the Chevrolet Dealer Buffalo Zone developed a revolutionary method for Corvette body repairs that would lower the cost of fiberglass repairs and improve dealer profit for these types of repairs. Chevrolet eventually commercialized their Corvette repair process and hired Molded Fiber Glass Body Co. of Union City, Pennsylvania to manufacture low cost molds for the 1963 - 1966 Corvette body panels.

The molds were made available by Chevrolet in late 1965 under the part number of 1050542. On February 21, 1966, Chevrolet Central Office sent a letter to all Regional and Zone Service Managers outlining the details of these new molds. Below are those documents.

1. "CORVETTE MOLD REPAIR KIT 1963-66" order blanks
2. "CORVETTE BODY REPAIR - SIMPLIFIED" booklets
3. "CORVETTE BODY REPAIR - SIMPLIFIED" posters

The purpose of the dealer distribution is to acquaint the majority of our dealers with the new simplified method of repair for Corvettes that have received body damage.

Any dealers that desire to purchase the mold kit should order them directly from Molded Fiber Glass Body Co., Union City, Pennsylvania on the white order blank. The dealer's check should be attached to the order form in the amount of \$420.00 and his address included. The dealer should retain the blue copy for his files and forward the pink copy to the Zone Service Manager. The kits will be shipped F.O.B., Union City, Pennsylvania upon receipt of the dealer's check and order.

The repair kit for making parts from the molds can be ordered through the General Motors Parts Warehouses under part number 1050452 at \$23.49 each.

All zones have received objectives for these mold kits 1963-66 and we are asking you to complete your objective as soon as possible.

A suggested dealer letter is attached.

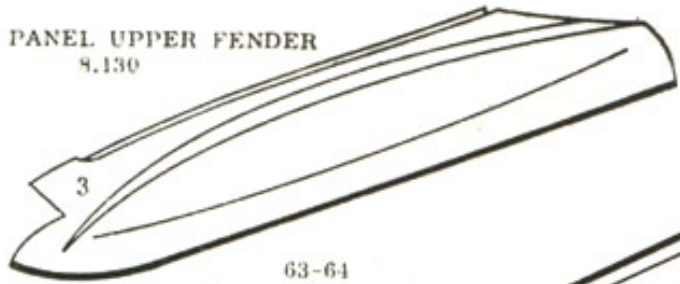

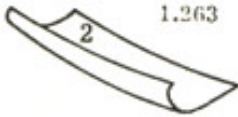
**PANEL UPPER GRILLE**

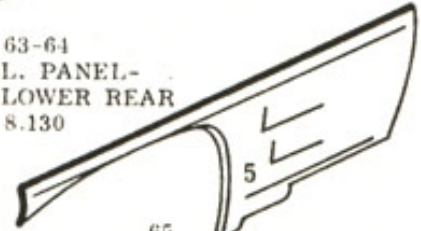
**R. & L. PANEL UPPER FENDER**

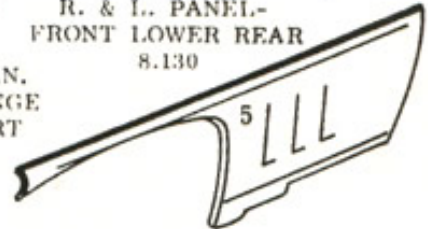
